Mountain View ATV Club, Inc. issues this permit for use on the leased property located in the Virginia City area. This document certifies that the holder of said permit is a member of Mountain View ATV Club, Inc. and has paid a yearly \$35 fee for use thereof. The permit holder has the right to use said property in accordance of the rules and regulations set forth by Mountain View ATV Club, Inc. which are listed below.

1. No alcoholic beverages or non-prescription (illegal) drugs. (Subject to automatic dismissal)
2. All ATV and motorcycle riders must adhere to all state laws, and when operating ATVs, no reckless operations, which would put other riders or their property in danger.
3. All ATV and motorcycle riders must wear a helmet and have the **custom-made permit sticker on left side of helmet at all times.**
4. ATV and motorcycle users must stay on the trails, no cutting or making new trails.
5. If ATV riders encounter a horse, rider must stop and cut engine off. Until the horse passes in order to not spook the horse and put the horse rider in danger, the engine must remain off.
6. Absolutely no littering on property or trails.
7. Users must respect said property by preventing damage to gates, cables, signage, etc.
8. Anyone under the age of 16 must be accompanied by an adult.
9. This permit or permit card must be with you at all times while on said property.
10. No hunting on Virginia City property.
11. Permit holders must present this document or permit card to **any club member** requesting proof of being a legal user of said property.
12. Any permit holder who violates these rules is subject to have his or her permit revoked.
13. Permits are issued on a yearly basis only. The fee is currently \$35 per year.

I further agree to reimburse you for all attorney fees and costs should I bring a legal action against you and lose.*
