Lee County - RECOMMENDATIONS

LEE COUNTY

There are a tremendous amount of OHV trails already in existence in the northwest corner of Lee County, primarily around the Pennington Gap area, which actually lead into and connect with trails in Kentucky. Immediate Action: Landowners need to be identified and permission granted to allow these trails to be opened to the public.

- Already in existence is the Hagan ATV Trailhead which offers a network of trails onto the top of Stone Mountain in Virginia Little Black Mountain? and accessing trails in Kentucky.
- A second trailhead recently closed but at one time provided access up onto Yellow Mountain.
- There are approximately 20 acres of property currently owned by the Town of Pennington Gap (just off Left Poor Valley Road) that could serve as a trailhead location which would provide easy access to existing trails leading to Yellow Rock and Stone Mountain.
- There is also potential to convert an old school into a lodging facility for ATV riders if the building is still structurally sound.
- There is strong interest in developing trails in the Pennington Gap area of Lee County. To this end, a multi-use trail is being developed on Stone Mountain. Funding has been awarded to construct the trail but an additional \$30,000 is necessary to conduct an environmental study. It is highly recommended that the state allow a portion of the overall funding to be used to conduct the necessary environmental study.
- · Funding has also been obtained to create a Greenway to connect Riverbend Shopping center with
- Leeman Field Park via the Powell River in the Town of Pennington Gap which, once completed, will serve as a wonderful asset to the community. The shopping center could accommodate outfitters for ATV'ing, canoeing, bicycling, & others.
- Leeman Field Park offers riding stables that are leased by Cumberland Horse Association. With ample parking, restroom facilities and picnic areas, this site will serve as an excellent trailhead for equestrian riders with the intent that one day horse trails might be developed from this site connecting with trails in Kentucky.
- Extend the Wilderness Road Trail An abandoned railroad corridor continues east of the trail terminus. It should be extended and incorporated into the trail system.
- Daniel Boone Wilderness Trail has a number of historically significant sites along the route that should be identified with interpretive signage and included on a website and other interpretive materials featuring the trail.
- There is potential for developing a Water Trails (Powell River) officials should work with river user groups to develop a canal trail for Powell/Clinch Rivers. Management plans should be developed that addresses law enforcement, education, camping, sanitation, access management, and maintenance.
- There is also potential for additional public boat launching locations and bank fishing opportunities.
- Unthanks Cave Natural Area Preserve should develop a karst trail and include interpretive signs which would allow a visitor to experience the cave without actually entering.
- Keokee and St. Charles should consider becoming OHV Friendly in order to revive the communities and spur economic development. Trail riders will need access to gas and food along the trail. The Pennington Gap Stone Mountain Trail proposes to connect to Keokee as an access point for Lake Keokee as well as accessing the existing trails.

SITE VISIT

On March 25th, 2009, toured portions of Lee County with Tina Rowe and Jack McClanahan.

Jonesville is the county seat. Population is less than 1,000 in the town and about 23,500 in the county. Ohter communities include Ben Hur, Dryden, Ewing, Keokee, Pennington Gap, Rose Hill, St. Charles and Blackwater. Portions of both Cumberland Gap National Historical Park and Jefferson National Forest are located in Lee County.

First stop upon coming through the Cumberland Gap from kentucky was the Wilderness Road State Park.









The Visitor Center offers travelers tourist info, a wonderful interpretive center, a gift shop and restroom facilities.









Martin's Station, a recreated fort, is located on the back portion of the property; buffalo can be seen as one enters the park and the Wilderness Trail is located directly behind the Visitor Center.

Camping: The park offers primitive group camping for groups of up to 50. Campers must bring drinking water; portable toilets are available, showers are not. Reservations can be made at the visitor center.

Trails at Wilderness Road State Park include:

- The Wilderness Road Trail, a 10 mile hiking, biking, & equestrian trail.
- The Indian Ridge Trail, a self-guided natural heritage trail.



Lee County - SITE VISIT



Potential Trailhead



There are 20 acres of property currently owned by the Town of Pennington Gap right off Left Hand Road that could serve as a trailhead location providing easy access to existing trails leading to Yellow Rock and Stone Mountain.

Trails in Pennington Gap Area - hiking, biking, ATV (these trails have all been mapped).

- Take Left Hand Road that runs along Stone Mountain then turn right onto Hwy 637 (left on Hwy 627 will take you to the High School and Hwy 58
- Cross RR multiple times
- Pass Yellow Rock where there was a trailhead next to a graveyard which is currently closed due to the owner getting tired of trash being dumped. Potential to reopen with proper policing.
- Turn right onto Occonita Road (fenced pond) then right again on Hubbard Church Road then right on Hubbard Springs Road.
- Will pass by Wagon Tunnel on the right. Across from it is the old site of a hotel located next to seven springs. The current owner is cleaning up the area and the springs have ferns and could make a nice picnic area in the future.
- Continue on Hubbard Springs (past a pay lake on the left)
- Go through a small tunnel and come to an intersecton. Turning left takes you to Hwy 58. Continuing right takes one to Hagan ATV trailhead. Ample parking for 12 to 15 cards and trailers. Trash cans at site. Cross over RR and go behind two homes to connect with trails. (home owners are very ATV friendly) White Rocks is a favored stop along the route?

Trail leads to Wagon Tunnel and to Yellow Rock.

Hell's Trail is in rough shape and washes out - considered a black diamond. There is a way to drop down and avoid it. Trail will take rider to Harlan Substation in Kentucky.

Lake Keokee Recreation Area (Clinch Ranger District of the George Washington and Jefferson Forests). The recreation area includes a 92 acre lake where Tiger Muskie, Large Mouth Bass, Catfish and Sunfish can be caught and a hiking trail around the lake. There are also vault toilets, central garbage, and two picnic units with tables and grills.

Keokee Hiking Trail: The trail is 3.7 miles long creating a loop around the lake. It is an easy trail primarily used for hiking and wildlife viewing which gets light use and is open year-round.
