- 2. U.S. Routes 19 and 460 in Tazewell County, 17.43 miles, from Bluefield to Tazewell;
- O.S. Rontes 19 and 460 in Tazewell County, 13.66 miles, from Yeacwell to Ckeypool Hill:
- 4. U.S. Route 460 in Tazewell County, 2.31 miles, from Claypool Hill to Cedar Bluff;
- U.S. Route 460 in Tazewell County, 1.50 miles, from Cedur Bluff to Virginia Route 67 at Richlands;
- Rouse 67 South in Town of Richlands on Railroad Avenue, 0.4 nules to signal light; continue straight 0.1 mile to Front Street

I am writing to you as a representative of the Town of Appalachia (Town Manager) and of Wise County (County Supervisor) regarding the captioned. Please consider this as a formal recommendation to extend the Virginia Coal Heritage Trail route to include Route 600 (Callahan Avenue) that takes in both coal communities of Derby and Stonega.

I have seen the letter to you written by the Wise County Tourism Committee, Elnine K. Swiney, Chairperson that, with great detail, defines the route. So as not to be redundant, please consider the following as additional reasons to include Route 600.

It had long been known and documented that Callahan Ave, leading from Appalachia to Kentucky was a route used early on by the local Indian tribes to travel between now Virginia and Kentucky. As the area began to be populated by early settlers, the route continued to be traveled by families moving between the two states. When coal was discovered to be in these mountains, the areas of Stonega and Derby thrived into bustling communities. Each community had its own hospital, school, church and community store. The coal companies built row houses for employees that still exist today. As you have been made aware, the community of Derby has been designated a Historical District. The original church in Stonega still stands today as a symbol of the past. Coal is still being mined today from the areas around each community. Several times a year, I am asked by folks who are passing through to drive them up Callahan so that they can wittiness first hand what a "coal camp" looks like. We here in the mountains are very proud of our heritage and would like nothing better than to share it with others.
